The following materials are posted under the SURVEYS tab on the Weebly VELI-STEM site: Brief instruction sheet Paper version of the survey (page 2 of instruction sheet) NOTE: If you give providers the paper version, you will collect completed forms and later enter the data from each survey into an on-line survey form on each provider's behalf.
		 Active on-line survey (for completion by child care providers or entry of completed paper forms by you) Preview of on-line survey (in case you want to look over the survey in its entirety without entering any real data) All surveys must be entered/completed by October 31, 2018. *CAVEAT: Given the relatively small communities of many Vermont libraries, the size of the pool of local child care providers/early educators may be limited. Please use your discretion in avoiding excessive surveying of the same providers over and over.
